AS KANSAS CITY'S ONLY DIAPER BANK, HAPPYBOTTOMS' ONGOING DIAPER DISTRIBUTION PROGRAM ALLEVIATES DIAPER NEEDS AND PROVIDES ACCESS TO OTHER CRITICAL SERVICES FOR KANSAS CITY AREA CHILDREN AND THEIR FAMILIES LIVING WITH HOUSEHOLD INCOMES LESS THAN 150% OF FEDERAL POVERTY LEVEL. CENSUS DATA SHOWS OVER 20,000 KANSAS CITY METRO AREA CHILDREN NEED DIAPER ASSISTANCE. GOVERNMENT SAFETY NET PROGRAMS (SNAP, WIC, MEDICAID) DO NOT COVER DIAPERS.
